

## Cookie Policy

### 1. General information

1. This policy applies to the website operating at the url address: [www.corees.pl](http://www.corees.pl)
2. The website operator and personal data administrator is: Corees Polska Sp. z o. o. with its registered office in Warsaw (00-032), ul. Przeskok 2 registered in Braniewo (14-500) at ul. Elbląska 12 lok. 1, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court in Olsztyn, 8th Commercial Division of the National Court Register (KRS) under the KRS number: 0000802559, with the REGON number 384300204, with the NIP number: 5821630785, share capital: PLN 50,000.00
3. Operator's e-mail address: [office@corees.pl](mailto:office@corees.pl)
4. The Operator is the Administrator of your personal data in relation to data provided voluntarily on the Website.
5. The website uses personal data for the following purposes:
  - o Maintaining a newsletter
  - o Presentation of the offer or information
6. The website performs the functions of obtaining information about users and their behavior in the following way:
  - o By voluntarily entering data in forms that are entered into the Operator's systems.
  - o By saving cookies on end devices (so-called "cookies").

### 2. Selected data protection methods used by the Operator

1. The places of logging in and entering personal data are protected in the transmission layer (SSL certificate). Thanks to this, personal data and login details entered on the website are encrypted on the user's computer and can only be read on the target server.

### 3. Hosting

1. The website is hosted (technically maintained) on the operator's server: Home.pl. The host ensures the implementation of all personal data protections specified by law, to the extent that it is responsible for maintaining the operator's server.

### 4. Your rights and additional information on how the data is used

1. In some situations, the Administrator has the right to transfer your personal data to other recipients if it is necessary to perform the contract concluded with you or to fulfill the obligations imposed on the Administrator. This applies to the following target groups:

- o companies providing marketing services to the Administrator

2. Your personal data processed by the Administrator no longer than is necessary to perform related activities specified in separate regulations (e.g. accounting). With respect to marketing data, data will not be processed for longer than 3 years.

3. You have the right to request from the Administrator:

- to obtain information whether your personal data is being processed
- about access to personal data relating to you,
- about information about the purpose of their processing,
- about the category of personal data processed,
- about information about the recipients of your personal data,
- o, if possible, information about the planned period of storage of personal data, and if not possible, criteria for determining this period
- for rectification of personal data,
- to delete personal data,
- for restrictions on the processing of personal data,
- to object to such processing
- about data transfer,
- about information about the right to lodge a complaint with the supervisory authority
- for information about automated decision-making, including profiling.

4. You have the right to object to the processing indicated in point 3 to the processing of personal data for the purposes of legitimate interests pursued by the Administrator, including profiling, however, the right to object will not be possible if there are valid legally justified grounds for processing. , interests, rights and freedoms that override you, in particular the determination, pursuit or defense of claims.

5. You may complain about the Administrator's actions to the President of the Personal Data Protection Office, ul. Ratuszowa 2, 00-193 Warsaw.

6. Providing personal data is voluntary, but necessary to operate the Website.

7. Activities involving automated decision-making may be undertaken in relation to you, including profiling, in order to provide services under the concluded contract and for the purpose of conducting direct marketing by the Administrator.

8. Personal data is not transferred from third countries or international organizations within the meaning of protection regulations personal data. This means that we do not send them outside the European Union.

## 5. Information in forms

1. The website collects information provided voluntarily by the user, including personal data, if provided.
2. The website may save information about connection parameters (time stamp, IP address).
3. In some cases, the website may save information that makes it easier to link the data in the form with the e-mail address of the user completing the form. In this case, the user's e-mail address appears inside the URL of the page containing the form.
4. The data provided in the form is processed for the purpose resulting from the function of a specific form, e.g. in order to process a service request or a commercial contact, register services, etc. Each time, the context and description of the form clearly indicate what it is used for.

## 6. Administrator's logs

1. Information about user behavior on the website may be subject to logging. This data is used for the following purposes administering the website.

## 7. Important marketing techniques

1. The operator uses statistical analysis of website traffic via Google Analytics (Google Inc. based in the USA). The operator does not transfer personal data to the operator of this service, only anonymized information. The service is based on the use of cookies on the user's end device. In terms of information about user preferences collected by the Google advertising network, the user can view and edit information resulting from cookies using the tool: <https://www.google.com/ads/preferences/>
2. The Operator uses remarketing techniques that allow advertising messages to be matched to the user's behavior on the website, which may give the illusion that the user's personal data are used to track him, but in practice, no personal data is transferred from the Operator to advertising operators. The technological condition for such activities is that cookies are enabled.
3. The Operator uses a solution that automates the operation of the Website for users, e.g., which can send an e-mail to the user after visiting a specific subpage, provided that he or she has agreed to receive commercial correspondence from the Operator.

## 8. Information about cookies 1.

The website uses cookies.

2. Cookies (so-called "cookies") are IT data, in particular text files, which are stored on the Website User's end device and are intended for using the Website's websites. Cookies usually contain the name of the website they come from, their storage time on the end device and a unique number. Cookies allow the identification of the computer from which the user entered the website. We use cookies that are necessary to enable the Website User to move around the website or to provide certain basic functions. We use cookies to enhance the functionality of the website by storing, for example, preferences. This gives us the opportunity to improve the performance and functionality of our website to ensure that the website performs better.  
The use of cookies is voluntary and can be disabled, however, for the sake of your safety and the protection of your personal data, we have introduced a principle according to which the use of our website depends on your voluntary consent to the use of cookies. If you do not consent to the use of cookies, you will not be able to use our website.

3. The entity that places cookies on the Website User's end device and obtains access to them is Website operator.

4. Cookies are used for the following purposes:

1. maintaining the Website user's session (after logging in), thanks to which the user does not have to visit every subpage re-enter your login and password;
2. achieving the objectives set out above in the "Relevant Marketing Techniques" section;
3. improving the performance and functioning of the website;

5. The Website uses two basic types of cookies: "session cookies" and "persistent cookies". "Session" cookies are temporary files that are stored on the User's end device until logging out, leaving the website or turning off the software (web browser). "Permanent" cookies are stored on the User's end device for the time specified in the cookie parameters or until they are deleted by the User.

6. Software for browsing websites (web browser) usually allows cookies to be stored on the User's end device by default. Website users may change the settings in this regard. The web browser allows you to delete cookies. It is also possible to automatically block cookies. For details, see your web browser's help or documentation.

7. Restrictions on the use of cookies may affect some of the functionalities available on websites Service.

8. Cookies placed on the Website User's end device may also be used by entities cooperating with the Website operator, in particular the following companies: Google (Google Inc. based in the USA), Facebook (Facebook Inc. based in the USA), Twitter (Twitter Inc. based in the USA).

11. The website may also have other "embedded" buttons and advertising materials, applications that enable website users to like, link and take other actions via social and related websites.

9. Cookies management – how to express and withdraw consent in practice?

1. If you do not want to receive cookies, you can change your browser settings. We reserve that disabling the use of cookies necessary for authentication processes, security, and maintaining user preferences may make it difficult, and in extreme cases, impossible to use the website.
